The Board reviewed the letter from Kishore Bathineni dated August 1, 2022, and a Demand for Board Action from his attorney dated October 10, 2022 regarding the finances of the 2019 Conference. The Board thanks Mr. Bathineni for his active interest in this important issue. The Board has requested the Chair to inform Mr. Bathineni thru his attorney that this Board deems the resolution of all issues related to the 2019 TANA Conference as a matter of serious interest and high priority and already spent considerable amount of time devoted to this issue and will continue to do so until it reaches a conclusion. The BOD appointed an internal audit committee to review these issues and is delving deeper into the recommendations of that report; the BOD has also appointed another committee last month to look into some additional issues and is waiting on its report. The Board has so far not reached any conclusions that any misappropriation of funds has happened. The appointment of a Coordinator for the 2023 Conference is the responsibility of the Executive Committee and the Board, at this time, has no reason to disagree with or override the decision of the Executive Committee. Once the Board finalizes its review of the financial issues of the 2019 Conference, they will be shared with all the members of TANA, which would include Mr. Kishore Bathineni.
