2. Mr. Chowdary Jampala moved the following

At a meeting of the Board of Directors (the "Board") of the Telugu Association of North America, Inc. ("TANA") held on the 10th day of February, 2023 the following resolution was adopted by a majority of the Board members:

WHEREAS: The Board previously considered a request from Krishna Gudipati, Murali Mohan Batchu, and Hazarath Darapaneni ("Plaintiffs 1-3") on October 10, 2022 to amend TANA's Bylaws to permit Plaintiffs to vote in the upcoming 2023 elections. After considering Plaintiff's amendment, the Board rejected the proposal.

WHEREAS: Plaintiffs 1-3 filed a Complaint for Permanent Injunction and Declaratory Judgment in the Circuit Court of Maryland for Baltimore City on October 14, 2022, along with a Motion for Temporary Restraining Order and Preliminary Injunction. The Court denied Plaintiffs 1-3's Emergency Motion for Restraining Order on October 28, 2022, but granted Plaintiff 1-3s' request for a Preliminary Injunction on November 10, 2022, which was continued again at a hearing on January 19, 2023.

WHEREAS: Plaintiffs 1-3 subsequently filed a Demand for Arbitration with the American Arbitration Association, and a final arbitration hearing is set for April 3-4, 2023, with a decision to be issued within 30 days of the hearing.

WHEREAS Plaintiffs 1-3 also filed a motion a Motion of Contempt Motion against TANA on February 9, 2023.

WHEREAS: Raju R. Alluri, Phanidhar Annamreddy, and Srinivas Yalamanchi ("Plaintiffs 4-6") filed a Demand for Arbitration with the American Arbitration Association, on January 23, 2023, that they and others similarly situated, be allowed the right to vote and participate in the TANA elections and also filed on February 9, 2023, a motion for preliminary injunction.

WHEREAS: Plaintiff Murali Mohan Batchu was approved by the TANA Executive Committee as a member on April 13, 2022, and is considered a Member in Good Standing according to TANA bylaws and is eligible to fully participate in the 2023 elections.

WHEREAS: The Board believes it is in the best interest of TANA to settle the current arbitration proceeding and reduce the cost of further litigation. Without admission of any liability, the Board moves to add Krishna Gudipati, Hazarath Darapaneni, Raju R Alluri, Phanidhar Annamreddy, and Srinivas C. Yalamanchi to the Eligible Voter List and further permit Krishna Gudipati, Hazarath Darapaneni, Raju R Alluri, Phanidhar Annamreddy, and Srinivas C. Yalamanchi to nominate or second candidates and to vote in the 2023 TANA elections.

NOW, THEREFORE, BE IT:

RESOLVED: That the Board hereby approves a resolution to resolve the pending litigation matters concerning Plaintiffs' eligibility to vote in the 2023 elections, thereby allowing Krishna Gudipati, Hazarath Darapaneni, Raju R Alluri, Phanidhar Annamreddy, and Srinivas C. Yalamanchi to participate, including nominating and seconding candidates and voting, in the 2023 TANA organizational elections. This resolution is solely limited to these two pending matters and should not be construed to apply to any subsequent challenges or grievances, and that will each be evaluated on their merits.
